1 Briefly describe the organization's mission: Xela AID empowers critically underserved families to break the cycle of poverty and become healthy, educated and self reliant. We work to ensure that every child in our focus area is educated, and every family is safe, healthy, and well-nourished; and we profoundly enrich the lives of our volunteers. Our programs span Education, Health, Clean Environment, Small Business Development, Emergency Relief, and Volunteerism.

4a (Code:) (Expenses \$ 511,940 including grants of \$) (Revenue \$ 431,665) EDUCATION: Objective: Create educational opportunities for children and families so that they may become self reliant. 1) San Martin Tots Preschool - A joint program with the First Lady of Guatemala's SOSEP, Xela AID provides and maintains this facility where 58 children receive instruction and hot meals twice a day. 2) Work Study Scholarship Program - Serving 160 children with the opportunity to attend school, afforded by sponsorships. Xela AID delivers funds twice a year to younger children, and monthly to high school and college students. 3) Leadership Development Program - Providing intensive leadership training and community service opportunities for 35 youth certificate program. Topics include public speaking, small business development, computer literacy, environmental ethics and more. 4) Women's Empowerment/Literacy - Provide literacy training for two dozen women; training is ongoing. Additionally provide training for marketable skills such as knitting, sewing and baking. 5) Xela AID Study Center - Tutoring serves 80+ children weekly. The Center is open 6 hours daily with home tutoring available. 6) Montessori Test School - Serving 25 children five days each week and providing teacher training.

4b (Code:) (Expenses \$ 123,879 including grants of \$) (Revenue \$ 105,381) HEALTH: Objective: Improve health to fuel self reliance. 1) Xela AID Clinic/Community Center - Provides life-saving and preventative health care to a community of over 30,000. Services include family medicine, OBGYN specialty, dental care, optometry, ultrasound, mental health care, prenatal care, family planning. Clinic participates in regional health programs, and de-louse/de-worm programs with more than 900 children treated each year. 2) Mental Health Program - Focuses on individual and group therapy, domestic violence prevention and deescalation of violence. These packs provide two changes of infantwear, two diapers, diaper pins, a bib, talcum powder and ointment against diaper rash. prevention of violence against children including sexual abuse. Program includes legal services. 3) Newborn Essentials/Infant Gift Pack Project - Newborns in Guatemala are commonly born with nothing to wear but old cloth. These packs provide two changes of infantwear, two diapers, diaper pins, a bib, talcum powder and ointment against diaper rash.
